BYLAW No. 842

A bylaw of the Regional District of North Okanagan to Establish and
Operate the Extended Service of Building Inspection

WHEREAS Section 818 of the *Municipal Act*, before its replacement, empowered the Regional District to exercise the provisions of Division V of Part 21 of the *Municipal Act*, being building regulations;

AND WHEREAS the Regional Board is desirous of continuing to exercise the provisions of Section 734 to 741 of the *Municipal Act*, as may be amended from time to time, within its Electoral Areas and member municipalities;

AND WHEREAS the Regional Board has deemed it expedient to establish "Building Inspection" as an extended service pursuant to the provisions of Sections 767(4), 789 and 794 of the *Municipal Act*;

AND WHEREAS the Regional Board has obtained the consents required under the provisions of Sections 799 and 800 of the *Municipal Act*;

NOW THEREFORE the Regional Board of the Regional District of North Okanagan in open meeting assembled, enacts as follows:

1. The Extended Service of Building Inspection is hereby established.
2. ~~The Extended Service Area established by Section 1 shall be contained within the boundaries of Electoral Areas "A", "B", "C", "D", "E", and "F" and within the boundaries of the City of Armstrong, District of Coldstream, City of Enderby, Village of Lumby, and Township of Spallumcheen.~~
The boundary of the Service Area established by Section 1 shall be the entire boundaries of Electoral Areas "B", "C", "D", "E" and "F".
3. ~~The member municipalities of City of Armstrong, District of Coldstream, City of Enderby, District of Coldstream, Village of Lumby, and Township of Spallumcheen and Electoral Areas "A", "B", "C", "D", "E", and "F" include the participating areas for this Extended Service.~~
Electoral Areas "B", "C", "D", "E" and "F" are the participants of this Service.
4. The annual operating costs for the Service shall be recovered:
 - (a) by the imposition of a fee or other charge;
 - (b) the balance after deducting the revenue obtained from the fee, or other charge, shall be recovered by the requisition of money under Sections 809 and 809.1 of the *Municipal Act* in the Extended Service Area, to be levied and collected under Sections 810(1) and 810.1(1).
5. This bylaw may be cited as ***"Building Inspection Extended Service Establishment Bylaw No. 842, 1989."***
