BYLAW No. 1883

A Bylaw to convert and establish the Twin Lakes/Grandview Bench Fire Protection Specified Area as a Local Service Area and to amend its boundaries

WHEREAS the Board has, by Bylaw No. 516, being the *“Twin Lakes/Grandview Bench Specified Area Establishment Bylaw No. 516, 1983”* established the Twin Lakes/Grandview Bench Fire Protection Specified Area;

AND WHEREAS pursuant to Section 774.2 [*Continuation of regional district services*] of the *Local Government Act*, R.S.B.C., 1996, Chapter 323, as amended, and Regulations passed pursuant thereto, states a regional district exercising a power to provide a service, may adopt a bylaw respecting that service which:

- (a) meets the requirements of Section 800.1 [*required content*] for a bylaw establishing a service, and
- (b) is adopted in accordance with Section 802 [*amendment or repeal of establishing bylaw*] as if it were a bylaw amending an establishing bylaw;

AND WHEREAS the Board of the Regional District of North Okanagan wishes to convert and establish the Twin Lakes/Grandview Bench Fire Protection Specified Area and amend its boundaries;

NOW THEREFORE the Board of the Regional District of North Okanagan in open meeting assembled, hereby ENACTS AS FOLLOWS:

CITATION

1. This bylaw may be cited as the *“Twin Lakes/Grandview Bench Fire Protection Specified Area Service Conversion and Establishment Bylaw No. 1883, 2003”*.

ESTABLISHMENT OF SERVICE

2. The Twin Lakes/Grandview Bench Fire Protection Specified Area created under Bylaw No. 516, 1983 is hereby established as the Twin Lakes/Grandview Bench Fire Protection Service Area for fire prevention and suppression.

SERVICE AREA BOUNDARIES

3. The local service area now converted and established by Section 2 shall be known as the Twin Lakes/Grandview Bench Fire Protection Specified Area and is the defined portion of Electoral Area “F” contained within the boundary shown outlined on the plan annexed hereto as Schedule “A”.
4. The Regional District is authorized to undertake and carry out or cause to be carried out and provide the local service of fire prevention and suppression within the said service area including construction of a fire hall and acquisition of fire equipment.
