## By-Law No. 1010

A by-law to merge Street Lighting Local Service Establishment By-Laws 858 and 919

WHEREAS the Regional Board of the Regional District of North Okanagan established local service areas for street lighting by the "Silver Star Street Lighting Local Service Area Establishment By-Law No. 858, 1989", and the "Knoll 2 Subdivision Street Lighting Local Service Area Establishment By-Law No. 919, 1990";

AND WHEREAS it is now deemed desirable to merge the said local service areas pursuant to Section 802(1.1) of the Municipal Act;

NOW THEREFORE the Regional Board of the Regional District of North Okanagan in open meeting assembled enacts as follows:

- The local service areas established by the "Silver Star Street Lighting Local Service 1. Area Establishment By-Law No. 858, 1989", and the "Knoll 2 Subdivision Street Lighting Local Service Area Establishment By-Law No. 919, 1990", are hereby merged, pursuant to the provisions of Section 802(1.1) of the Municipal Act.
- 2. The boundaries of the merged areas, which are contiguous, are those more particularly described on Schedule "A" attached hereto and forming part of this by-law.
- 3. The maximum amount that may be requisitioned for annual operating costs shall not exceed the product of a levy of \$0.50 for each \$1,000 of net taxable value of land and improvements included in the service area.
- 4. The areas merged under this by-law are deemed to be one local service area known as the Silver Star Mountain Street Lighting Local Service Area.
- 5. This by-law may be cited as the "Silver Star Mountain Street Lighting Local Service Area Merger By-Law No. 1010, 1991".


