

# REGIONAL DISTRICT OF NORTH OKANAGAN

## BYLAW No. 1954

A bylaw to establish a street lighting service in and for the Ridge Subdivision in the Silver Star Mountain Community within Electoral Area "C".

---

**WHEREAS** Section 796 [*General authority for services*] of the *Local Government Act* authorizes the Regional District Board to operate any service that the Board considers necessary or desirable for all or part of the Regional District;

**AND WHEREAS** Section 800 [*Establishing bylaws required for most services*] of the *Local Government Act* provide for the adoption of a bylaw to establish a new Regional District service;

**AND WHEREAS** a request has been received for the provision of street lighting in and for the Ridge Subdivision in the Silver Star Mountain Community within Electoral Area "C";

**AND WHEREAS** a valid petition has been received and certified by the Corporate Officer of the Regional District pursuant to Section 797.4 [*Petition for electoral area services*] and Section 212 [*Petition for local area service*] of the *Community Charter*;

**NOW THEREFORE**, the Board of the Regional District of North Okanagan, in open meeting assembled, hereby ENACTS AS FOLLOWS:

### CITATION

1. This Bylaw may be cited as the "***Ridge Subdivision Street Lighting Service Establishment Bylaw No. 1954, 2004***".

### ESTABLISHMENT OF SERVICE

2. The street lighting service for the Ridge Subdivision in the Silver Star Mountain Community is hereby established as the Ridge Subdivision Street Lighting Service.
3. The Regional District is hereby authorized to undertake and carry out or cause to be carried out and provide a street lighting service within the said service area.

### DESCRIPTION OF SERVICE

4. The service established by this Bylaw is limited to the planning, implementation, operation and maintenance of a street lighting service for the properties within the boundaries of the service area.

### SERVICE AREA BOUNDARIES

5. The area of the local service established by Section 2 shall be known as the Ridge Subdivision Street Lighting Service Specified Area and is defined as all territorial area included within District Lot 5264 in Electoral Area 'C' as shown outlined on a plan attached hereto as Schedule "A".

**PARTICIPANTS**

6. The participants of this service are Electoral Area 'C' of the Regional District of North Okanagan.

**COST RECOVERY**

7. The annual costs of the service shall be recovered from the said service area by the requisition of money under Section 806 [*Requisition of funds for electoral areas*] of the *Local Government Act* to be collected by a property value tax to be levied and collected under Section 806.1 [*Collection in electoral areas*] of the said *Act*.

**MAXIMUM REQUISITION**

8. The maximum amount that may be requisitioned under Section 5 shall not exceed a levy of \$7,214 Dollars or (\$8.0424) per One Thousand Dollars (\$1,000.00) of the net taxable value of land and improvements included in the service area, whichever is greater.

**SERVICE PROVISION**

9. The Regional District may provide street lighting services through its own resources or by entering into contractual agreements.

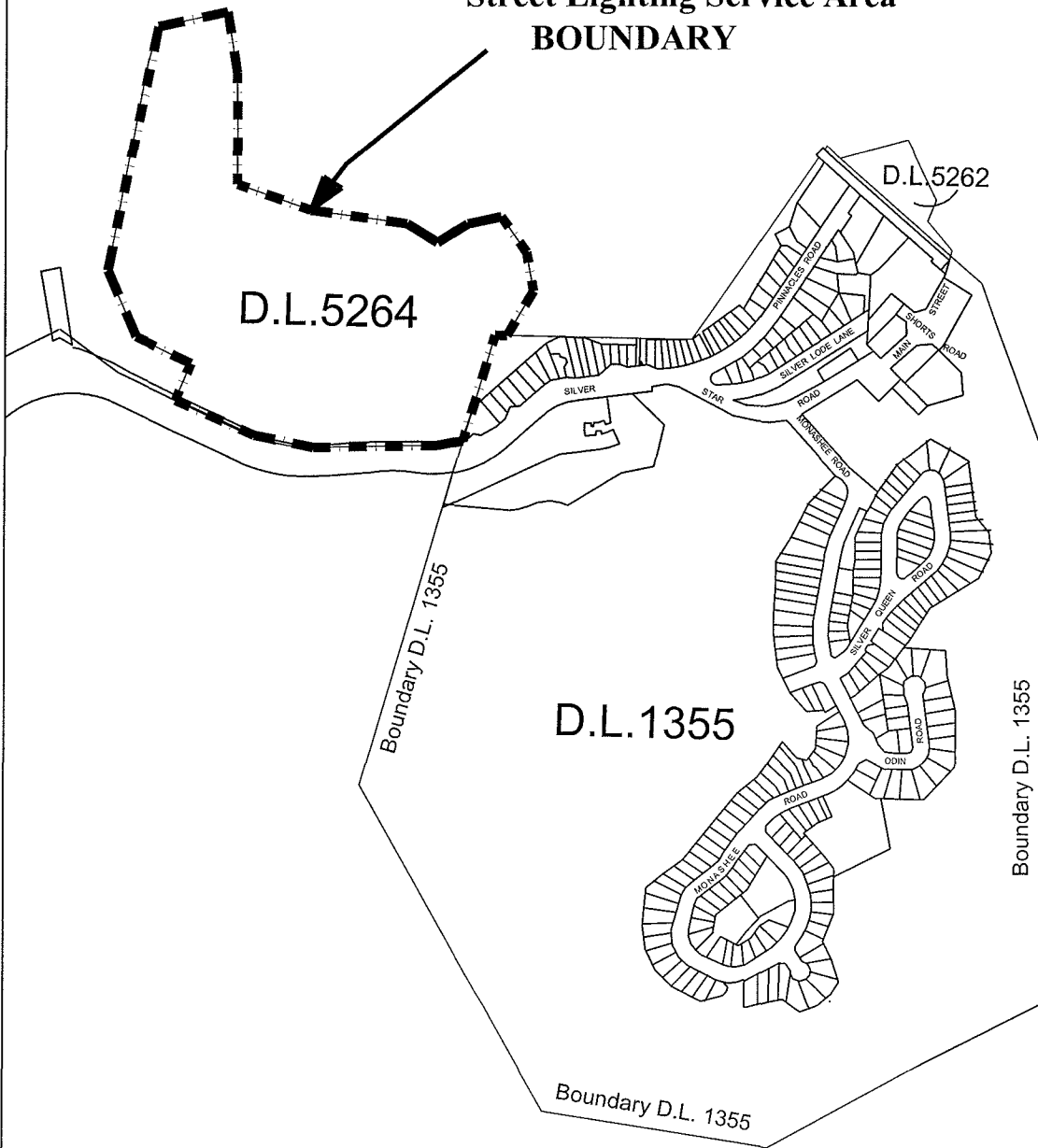
